THE RESIDENTIAL PROGRAM USES A VARIETY OF EVIDENCE-BASED MODELS INCLUDING TARGET AND RESTORATIVE PRACTICES TO HELP ADDRESS THE CHALLENGES FACED BY YOUTH WITH HISTORICAL TRAUMA, BEHAVIORAL CHALLENGES, AND MENTAL HEALTH AND SUBSTANCE USE TREATMENT NEEDS.
